

# NXTZON - Terms and Conditions

Welcome to NXTZON. Before joining as a Distributor or Customer, please read these Terms and Conditions carefully. By using our services, you agree to the rules and conditions mentioned below.

## Article 1: Definitions

- 1.1 "Company" refers to NXTZON, a co-commerce and e-commerce platform.
- 1.2 "Distributor" refers to any individual who purchases and sells NXTZON products.
- 1.3 "Customer" refers to any individual who purchases products from NXTZON or its authorized Distributors.
- 1.4 "Products" include all goods and services provided by NXTZON.

## Article 2: Becoming a Distributor

- 2.1 To become a Distributor, an individual must:
  - a. Be at least 18 years old;
  - b. Provide accurate and valid information in the application form;
  - c. Agree to these Terms and Conditions;
  - d. Purchase a starter kit or initial product order.
- 2.2 The Company reserves the right to accept or reject any application.

## Article 3: Distributor Responsibilities

- 3.1 Distributors must:
  - a. Comply with all applicable laws and regulations;
  - b. Conduct business in a professional and ethical manner;
  - c. Provide accurate information to customers;
  - d. Avoid false or misleading claims about products or the company;
  - e. Refrain from illegal or unethical business practices.
- 3.2 Distributors are independent contractors and not employees of the Company.

#### Article 4: Product Sales

- 4.1 Distributors should sell products at the Companys recommended retail price (RRP).
- 4.2 No product may be sold below RRP without prior Company approval.
- 4.3 Distributors are responsible for all taxes arising from their sales.
- 4.4 If a product is not put on sale within 30 days of purchase, it will be shipped to the Distributors registered address within the next 15 days.

#### Article 5: Income and Reward Plan

- 5.1 NXTZON offers an income plan that rewards Distributors for product sales and team building.
- 5.2 Full details of the income plan are available on the Companys website.
- 5.3 The Company may modify the plan at any time.

#### Article 6: Termination

- 6.1 The Company can terminate any Distributor account for rule violations or misconduct.
- 6.2 A Distributor may terminate their account by submitting a written request.

#### Article 7: Agreement Scope

- 7.1 These Terms and Conditions represent the entire agreement between the Company and the Distributor.
- 7.2 All previous agreements, written or verbal, are replaced by this document.

#### Article 8: Conduct and Behavior

- 8.1 Distributors must maintain a professional approach at all times.
- 8.2 Any activity that harms the Companys reputation will result in action.

#### Article 9: Social Media Policy

- 9.1 Distributors must follow the Companys social media guidelines.
- 9.2 Posting misleading or defamatory content about NXTZON is prohibited.

#### Article 10: Customer Data Privacy

- 10.1 Distributors must maintain strict confidentiality of all customer data.
- 10.2 No data can be shared with third parties without written permission.

#### Article 11: Coupons and Tasks

11.1 Each completed task will provide the Distributor with 36 coupons of different values.

11.2 If a second task is completed, the previous set of coupons will be deactivated and replaced by the new set.

#### Article 12: Returns and Refunds

12.1 NXTZON offers a 30-day money-back guarantee on all products.

12.2 Refund requests must be made within 30 days of product receipt.

12.3 Any earned income (coupon income, level income, or 3-day income) will be deducted from the refund.

12.4 Refunds will be processed only after admin approval.

#### Article 13: Intellectual Property

13.1 Distributors must not infringe upon the Companys trademarks, logos, or content.

13.2 Unauthorized use of intellectual property may result in legal action.

#### Article 14: Updates to Terms

14.1 The Company reserves the right to modify these Terms and Conditions at any time.

14.2 Changes will be effective immediately upon being posted on the Company website.
